INVITATION TO BECOME A FUNDRAISER

Welfare organisations are under tremendous pressure to raise funds in order to continue with the services they provide. You are hereby invited to be part of the solution.

Any individual or organization can contribute by signing a debit order form whilst simultaneously inspiring others to get involved with raising funds. Any registered NGO/ NPO can be nominated as a beneficiary. Eighty percent of the contribution will be paid out to the relevant charitable organization.

For every signed debit order recruited by you, you will get a cash-back bonus. There are three options:

Bronze Bonus: Fundraisers will receive a bronze bonus when they recruit someone to sign a debit order in favor of an NGO/ NPO. Three percent of that debit order will serve as a bronze cash-back that will be netted off from the fundraisers current debit order. There is no limit on the number in people who can be recruited in this way.

Silver Bonus: Fundraisers will receive a silver bonus when the person they've recruited, recruits another. Five percent of this debit order will be paid out as a silver cash-back bonus to the original recruiter. There is no limit on the number of people who can be recruited in this way.

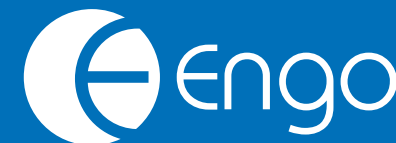
Gold Bonus: The golden bonus is the pinnacle of the three bonuses. You receive this when the person recruited by the fundraiser starts receiving silver bonuses. The original fundraiser's cash-back bonus will be seven percent of each debit order that the Silver fundraiser has recruited. His/her cash-back bonuses will however persist to be three percent (Bronze Bonus) and five percent (Silver Bonus) for persons recruited in the way described in the previous paragraphs. There is no limit on the amount of people who can be recruited in this way. (See Terms and Conditions)

The fundraiser will receive an annual IT3 certificate for income tax purposes.

Hospital Care
Hospitaalsorg

Engo's Hospital Care focuses on visiting people who are hospitalised in Bloemfontein, but do not live in the city. Support is also given to the visiting family members of the patient. All the big hospitals in Bloemfontein are visited daily. About 10 000 people are visited annually.



Disabled Care

Four centres in the Free State care for almost 100 adults with disabilities. These centres focus on skills development, improvement of quality of life, healthy relationships and ministering spiritual needs. Disabled Care's services also include a day care centre for multidisabled children (below 18 years of age).

ENGO'S SEVEN SERVICES



Child & Youth Care
Kinder- & Jeugsorg

Engo's Child and Youth Care programme takes care of orphans and children who were removed from their parental homes by the Children's Court. They reside in 34 youth care centres across the Free State.

About 800 children between the ages of 0 and 18 years are being cared for in these centres. Additional support and care to approximately 3000 children.



Family Care
Gesinsorg

Child Protection and Family Care offices assist individuals, groups and communities and offers a variety of services including parental guidance and HIV/Aids programmes, alcohol and drug abuse prevention, services regarding pregnancy crises, foster care services, counselling for victims of sexual abuse and many more. There are 13 family care offices in the province, serving communities in 17 towns.

There are 22 Elderly Care centres across the Free State, providing essential services to almost 10 000 senior citizens annually. Services include feeding schemes, health services, life skills programmes, personal care and residential care.

GOAL:

The goal of Helpcor Trust is to raise funds for Non Profit Organisations.

TAX STATUS AND BENEFITS:

Section 18 A certificates will be provided.

What does it mean to have section 18 A status?

Engo Free State is a section 18A-approved organisation. A taxpayer making a bona fide donation in cash or in kind/in natura to HELPCOR Trust / Engo Free State, is entitled to a deduction from taxable income up to a maximum of 10% of your taxable income amount.

Corporate Social Responsibility plays a role on BEE score sheets. Helpcor Trust aims to assist our donors to, through the contribution made, increase the points that are allocated to the Corporate Social Responsibility section on their BEE score sheets.

TERMS AND CONDITIONS

Any reference to the singular includes the plural. Any reference to one gender includes the other. The donor/fundraiser by signing the debit order instruction agrees to pay any banking charges relating to the debit order instruction. The donor/fundraiser confirms that there is no employer-employee relationship between the donor /fundraiser and Helpcor Trust and/or ENGO. The debit order may be cancelled by the donor/fundraiser by giving thirty days' notice in writing. The donor /fundraiser understand that every donor/fundraiser may only have three levels below him, but may expand each level indefinitely. The donor/fundraiser understands that if the donor /fundraiser or someone on a lower level cancels his debit order or if it expires, the cash-back bonus for the debit order cancelled will cease to be paid with immediate effect.

ASSIGNMENT

I acknowledge that the party hereby authorized to effect the drawing(s) against my account may not cede or assign any of its rights to any third party without my written consent. I acknowledge that I may not delegate any of my obligations in terms of this contract/authority to any third party without prior written consent of the authorised party. I understand that the withdrawals hereby authorized will be processed by a computer through a system known as the Bankserv magnetic tape service and I also understand that details of each withdrawal will be printed on my bank statement or on an accompanying voucher. Receipt of this instruction by you shall be registered as receipt thereof by my bank (whichever it is or will be). I acknowledge further that upon me no longer contributing for whatever reason any benefit that accrued to me will terminate with immediate effect and that any rights or benefits that I am entitled to or may have become entitled to, will not be transferred to any third party.
